


ATC sent letters requesting answers on four significant policy matters relating to human rights in Tibet to parties running candidates in seats of interest to ATC's supporters and the Tibetan Community. Where we did not receive a response to our emails from a party, their score is based on their policies, public statements and parliamentary voting record.

Will your party pledge to only recognise a future Dalai Lama chosen by Tibetan people using Tibetan Buddhists

Australian Labor Party





Labor support the ability of religious and spiritual communities to choose their leadership without interference. The Albanese Labor Government has made clear our position, which is that governments should not interfere in the selection of religious leaders, including the Dalai Lama.

The Liberal -National Coalition





The Coalition raised questions in Senate Estimates regarding the future succession of the Dalai Lama, including concerns about efforts by the PRC Government to select or appoint Tibetan Buddhist leaders as interference in the freedom of their religion to choose its own leaders. The Coalition is a committed advocate for freedom of religion or belief for all individuals worldwide.

The Australian Greens





The Australian Greens only recognises a Dalai Lama appointed via Tibet Buddhist traditions and practices, without interference by the Chinese government. The Greens will continue to advocate that the Australian Government also take that approach, including exploring legislative options in the coming Parliament.

**Utilisation of Australia's Magnitsky sanction laws** 

Will your party, where appropriate, utilise Australia's Magnitsky laws to sanction those CCP officials abusing the human rights of Tibetans, including those already sanctioned by Australia's allies?

#### <u> Australian</u> **Labor Party**





Consistent with longstanding and bipartisan practice, the Albanese Labor Government does not speculate on potential sanctions. Sanctions are one way to send a message, but they are not the only way, or necessarily the most effective way, to influence change.

## The Liberal -National Coalition





The Coalition has repeatedly offered, directly and publicly, bipartisan support to the Government to apply appropriately targeted sanctions to ensure those who have committed human rights abuses are held accountable.

The Greens have consistently called for application of targeted sanctions on Chinese officials or companies responsible for severe human rights abuses, including those committed against

## **Fusion Party**





Australia has been conspicuous in not upholding the Magnitsky Sanctions, especially where the financial interests are involved. Fusion stands implacably opposed to this selective uptake of the UN conventions, and so recognises the need, but also realistically predicts the obstacles, to insisting on the Magnitsky Sanctions being invoked against China in regard to its actions in Tibet.

#### **Heart Party**





The HEART Party supports government transparency and accountability, and advocate for decisions to be made by our elected representatives, not by international organisations. The HEART Party believe in reassessing foreign trade agreements and reviewing the roles of global institutions such as the United Nations to ensure Australia's sovereignty and moral responsibility are upheld. Any use of sanction powers should reflect these values and be applied in a manner consistent with justice and independence.

#### Gerrard Rennick People First Party





Yes—People First believe Magnitsky-style sanctions should be applied proportionately against proven human rights abusers, including CCP officials where justified.



Australian Labor Party





The Albanese Labor Government consistently refers to Tibet in [UN] documents and Australian Government policy documents, and has no plans to change this longstanding practice.

**Human rights policy** 

What is your party's publicly stated policy position on Tibet and does your party have any concrete actions it plans to undertake regarding the multitude of human rights abuses against Tibetans?

#### <u> Australian</u> **Labor Party**





The Albanese Labor Government have consistently raised its concerns about the erosion of rights and freedoms in Tibet publicly, bilaterally with the Chinese Government at the highest levels, and in multilateral forums. The Albanese Labor Government has also increased Australia's advocacy efforts in multilateral forums such as the Human Rights Council at the UN General Assembly committees.

## The Liberal -National Coalition





The Coalition remains deeply concerned about the human rights situation in Tibet. The Shadow Minister for Foreign Affairs met with the Hon Penpa Tsering, of the Tibetan Government in Exile in 2023 to hear directly from him about issues of concern. The Coalition will continue to promote human rights and freedom of religion in Tibet.

#### The Australian Greens





The Greens have consistently advocated for the human rights of Tibetans, and advocated for greater action by the Australian Government to respond to the serious human rights violations being committed by the Chinese Government. The Greens have consistently raised the plight of Tibetans in speeches in the Australian Parliament and will continue to do so in the coming Parliament.

#### Animal Justice Partu





The Animal Justice Party runs by our KERN principles. This stands for Kindness, Equality, Rationality and Non-violence. Anything that breaks those principles we are against. We do not agree with wars and the loss of life of animals or humans. We object to all atrocities against humans, animals and our planet.

#### **Fusion Party**





Fusion will advocate that Australia honours all the UN Conventions to which Australia is a signatory much more firmly and unequivocally - not just with words, but with decisive action, insistence and engagement. In respect of "concrete actions" we plan to undertake re Tibet, Fusion will seek advice on this by consulting with people who know the situation best and who have the solutions to propose - like the Australia Tibet Council.

#### Legalise Cannabis Party




